Prior to listing, an ETF must be authorised for distribution in each host jurisdiction, which is often a time and resource consuming challenge.

Once authorised, these ETFs can be listed in each target jurisdiction. Depending on the distribution strategy, your ETFs may need to be listed on several stock exchanges.

Each exchange has its own listing procedure and ongoing listing maintenance obligations.

Stock exchange listing and maintenance procedures are not harmonised within Europe, which has instigated complexity for cross- border ETF distribution strategies.

With regards to the authorisation, distribution, and stock exchange listing requirements, you will have to understand and satisfy a host of differing regulatory, reporting and tax requirements across multiple jurisdictions. You will need the support of skilled and experienced local experts to optimise the market entry and ongoing compliance processes for your ETFs.
